PHATLALATSO EA LIPHETOHO TSE TLANG MEKHOENG EA PHETISETSANO EA LICHELETE LIPAKENG TSA LINAHA TSA CMA (COMMON MONETARY AREA)

Sehlopha sa linaha se tsejoang e le Common Monetary Area (CMA) se kenyeletsa linaha tse latelang; Eswatini, Lesotho, Namibia, le South Africa. Komiti e ikarabellang ho phetisetsano ea lichelete lipakeng tsa linaha tsena (Cross-Border Payments Oversight Committee - CPOC) e entse qeto ea ho khina phetisetsano ea lichelete tsena ka tsela eo e neng e le ea nakoana ea Electronic Funds Transfer (EFT) e tloaelehileng. Phetoho ena e tlameha ho etsahala pele ho la 16 Loetse 2024. Ka lebaka la phetoho ena, ho hula chelete (li-Debit Order) le li patala ka EFT li tla ameha. Ho tloha ka la 16 Loetse 2024, phetisetsano ea lichelete lipakeng tsa linaha tsena ha e sa tla tšoana.

Li debit order tse lipakeng tsa linaha tsena ha li sa tla etsahala ka tras'a lipheto ho tse tlang. Bafani ba litšebeliso ba nang le makala ka har'a naha ea Lesotho ba lebeletsoe/ khothaletsoa ho thusana le makala a joalo ho hula lichelete tsa bareki, ho sa natsehe hore na litumellano tsa mokoloto li entsoe makaleng a naheng e fapaneng ea CMA. boo mofani oa litšebeliso a senang lekala ka hare ho naha ea Lesotho, o tla lebelloa/ khothaletsoa ho bula polokelo bankeng e Lesotho hore ka eona a tle a khone ho tsoelapele ho hulela bareki ho li account tsa bona tse Lesotho, ho ipapisitsoe le melao e tšebetsong e amanang le phetisetsano ea lichelete (Lesotho Payment Clearing House Rules).

Liphetsisano tsa lichelete ho linaha tsena li tla tlalehoa ho Banka e Kholo ea naha, joalo ka ha e le lipehelo tsa melao e amehang (Exchange Control Legislation).

1. Phetisetsano ea chelete ka marang-rang (EFT) e tla nne e tsoelepele ho etsahala, phapano e tla ba hore ho se ho tla hloka hlahala likhato tse eketsehileng ka ha phetisetsano ena e tla be e se e le ea mofuta oa Global Payment transfer.
2. U tla tsoelapele ho amohela chelete ka marang-rang ho tsoa ho linaha tsa CMA, feela e tla kena ese ele ea mofuta oa Global Payment.
3. Litefiso le ho hula chelete lipolokelong tse Lesotho ha ho sa tla fumaneha ho bafani ba litšebeliso ba seng Lesotho, ntle le hore ba imatahanye le makala a bona a Lesotho, kapa ba bule lipolokelong naheng ea Lesotho.
