



## AN OPPORTUNITY TO INVEST IN GOVERNMENT OF LESOTHO SECURITIES

In an effort to develop the domestic market, the Central Bank of Lesotho, on behalf of the Government of Lesotho, continues to undertake reforms that are aimed at deepening the financial markets in line with regional developments. The Central Bank of Lesotho (CBL) issues Treasury Bills and Treasury Bonds to raise money for the Government.

## TREASURY BILLS

### What are Treasury Bills?

Treasury Bills (T-Bills) are short-term government securities. CBL currently issues T-Bills with maturities of 91, 182, 273 and 364 days. These securities are issued at a discount and redeemable at face value on maturity. T-Bills are auctioned twice a month, subject to applicable terms as specified on the announcements that are regularly posted on the CBL website. T-Bills are preferred by investors because they are backed by the Government and constitute a risk-free investment. As a result, the T-Bills tend to be highly marketable and liquid in that they are always in high demand and can easily be traded (bought and sold) in the secondary market.



## TREASURY BONDS

### What are Treasury Bonds?

Treasury Bonds (T-Bonds) are medium to long-term government securities. CBL traditionally auctions T-Bonds quarterly, in the maturities of 3, 5, 7 and 10 years, so prospective investors should regularly check for upcoming auctions. Currently, T-Bonds pay interest semi-annually on the face value held during the life of the bond. T-Bonds may be issued at a discount, par or premium depending on the prevailing market circumstances at the time of sale. They are listed at the Maseru Securities Markets (MSM) to facilitate secondary trading. The Central Bank of Lesotho issues an annual auction calendar that is available on the Bank's website (<https://www.centralbank.org.ls>).

## PARTICIPATION IN THE TREASURY SECURITIES MARKET

### Who can invest?

Everyone is free to participate in the treasury securities market as long as they meet the minimum bid requirements. Participants could be individual investors (18 years and above), companies, banks, insurance companies, non-bank financial institutions, NGOs, corporations and societies. Non-residents are also eligible to participate provided they hold an account with a local commercial bank. ### Auction

All auctions take place at the Central Bank of Lesotho. For both T-Bills and T-Bonds, auctions take place on a Wednesday at 09:00 a.m. while payment and settlement take place on the same day before the close of business. The results are announced for both the successful and unsuccessful bidders at 11:00 a.m. on the auction date. Successful bidders are expected to collect their "Award Advice" from the Central Bank of Lesotho and settle on the same day (T+0) of the auction. Settlement and redemption for the securities are done through commercial banks.

### Application to Bid

The Central Bank of Lesotho invites bids by issuing press releases 7 days before every auction. Tenders are made by completing the Government of Lesotho Securities Bid Form (CBL/TBR/I) available at the Central Bank of Lesotho. The Bank must receive all bids before the deadlines stated in the auction announcement. Late applications will not be accepted. For all securities, each bid must state the face value. They must equal or exceed the minimum threshold of M5,000 and be in multiples of M100 thereafter. Separate bid forms should be completed for each tenor e.g. 91, 182, 273 and/or 364 days.

## REQUIREMENTS FOR TRADING IN TREASURY BILLS/BONDS

### 1. Individual Investors

- Investor's identification (National ID / Passport)
- A bank account held at any local commercial bank


### 2. Societies

- Certificate of Registration
- Society's Constitution
- Society resolution by members to invest
- Bank Account Confirmation Letter
- Identification of all signatories

### 3. Companies

- Certificate of Incorporation / Trader's License
- Bank Account Confirmation Letter
- Identification of at most three signatories





## TAXATION

### Is there any Tax payable on Treasury Securities?

Withholding Tax is payable on interest income earned from investment in treasury securities. The rates are 10% and 15% for residents and non-residents respectively. The interest that is earned at maturity or as coupon payments will therefore be net of withholding tax.

## DISINVESTMENT OF TREASURY SECURITIES

### Can one trade the Treasury Securities?

#### Secondary Market Trading

The secondary market for securities exists and any person who holds such securities is free to trade, exchange or transfer them with other investors. They can be traded amongst investors "over-the-counter" or through a registered broker on MSM.

#### Rediscounting

In the event, an investor needs to redeem their securities before they mature and is unable to find a buyer in the secondary market, the Central Bank of Lesotho can buy the securities back as a last resort at a penal rate of interest only if 75% of the holding has elapsed.

## AT MATURITY

### What happens upon maturity of Treasury Securities?

Upon maturity, the T-Bills net proceeds (principal and interest) are deposited into the investor's commercial bank account. For Treasury Bonds, coupon payments shall be made semi-annually until the security matures, at which the principal shall be paid back to the investor. If an investor wishes to continue investing, then a new application has to be completed to re-invest the security

### What are the benefits of investing in Treasury Securities?

As an investment instrument, treasury securities have the following advantages:

- o They are free-risk investment
- o The rate of return is competitive
- o They can be pledged as collateral with third parties (banks)
- o They are transferable and negotiable



Motseteli o tlatsa foromo ea boiketo (CBL/TBR/I) e fumanehang Bankeng e kholo.. Likopo tse joalo li tlameha ho finyella Bankeng letsatsi pele ho fantisi. ## Mokhoa Oa Thekiso

Fantisi ea matsete a nako e khuts;oane (Treasury Bills) e etsoa habeli ka khoeli, ha ea matsete a nako e telele e ts'oaroa hang ka likhoeli tse tharo. Fantisi li ts'oareloa Bankeng e Kholo ea Lesotho ha ele Laboraro bekeng ka hora ea borobong (9:00 a.m.). Sephetho sa fantisi ka 'ngoe se phatlalatsoa letsatsing lona leo la fantisi, hona ho etsahala hang kamorao ho hora ea leshome le motso o mong (11:00 a.m.). Ba atlehileng ba fumants'oa mangolo a pakang hore ba se bana le matsete Bankeng e Kholo. Hang kamora ho phatlalatsa ba atlehileng, chelete eo ba e tsetelang e huloa ho tsoa polokelong ea motseteli ka mong le banka ea hae.

## Melemo ea ho tsetela matseteng a 'Muso ke efe?

## LEKHETHO

Motseteli ka mong o lebeletsoe ho lefa lekhetho holima tsoala eo a tlang ho e fumana holima chelete ea hae ea letsete. Ho motseteli eo e leng moahi oa Lesotho ka molao, lekhetho lena le nka lintla tse leshome (10%) lekhelong ka leng la tsoala. Ka ho le leng ha motseteli ele moahi oa naha e 'ngoe kantle ho Lesotho, o lebeletsoe ho lefa lintla tse leshome le metso e mehlano (15%) lekhelong la tsoala. Ka hona motseteli o tla fumana tsoala e se e ntsitse lekhetho nakong eo letsete le butsoang.

## THEKISO EA LETSETE PELE LE BUTSOA

### Na motseteli o lokolohile ho rekisa letsete pele le butsoa?

Thekiso ea matsete pele a fihlela nako ea ho butsoa e buletsoe, 'me sena motseteli a ka se etsa le Maseru Securities Market kapa pakeng tsa bona ba le babeli moo batla tsebisa Banka e kholo.

Boemong bo letsete le seng le haba ho butsoa, Banka e ntsena le hona ho ka lereka hape e se le mothati oa qetela haeba motseteli a sa fumane e mong ea ka rekang, 'me ho tlaba le kotlo boemong bo joalo.

## HA LETSETE LE BUTSOA
